Gear check prior to riding **Complying helmets must be worn** •ASSA3838 standard•EN1384 standard, made in 2015 or older•EN1384 standard plus the VG1 standard•VG1 standard•ASTHF1163 standard •ARB HS 2012standard•PAS 015 BSI Kite marked.
- **Open Riders** – All Non-Pony Club members, and any Pony Club member who cannot show their Pony Club card or prove Pony Club membership must fill in the Liability Declaration .Please bring the completed form to the office on the day. If a form needs to be provided the cost will be \$3 [Liability form Here](#)
- **\$15 PER DAY** Day Attendance Fee is due UNLESS you are a financial member\* of EV/EA; HRCVA; AHS; SHCA; AERA; an Interstate Pony Club; or can prove personal Liability Cover of at least \$10,000,000.
- **\*\*\*Must produce proof on the day at the office prior to riding\*\*\***
- Riders without adequate Insurance Cover pay \$15 **PER DAY** for Liability Only cover for the duration of the clinic. (Not personal Medical) and complete the Day Participant Waiver.
- PCAV club member cards must be inspected at the secretary's office prior to riding
- PCAV Insurance Policy specifically states anyone not following PCAV Rules may be left uninsured.
- No refunds without a vet or medical certificate. This certificate must be received within 7 days of event
- Dogs but must be leashed at all times
- Lunging allowed in designated area- round yard
- No stallions, colts, rigs or mares with foals at foot. Companion animals only with the organising committees approval prior to the clinic
